



Technology Equipment Use Agreement

1. Property

I understand that the use of High School provided technology is a privilege, not a right. I understand that High School provided technology equipment, including, but not limited to, laptop computers, thin clients, e-readers, etc., including chargers are provided for use during the school year. Such equipment shall remain the property of NexTech High School.

I understand that the following policies apply to the use of all Academy issued technology at all times whether inside or outside the Academy premises. All technology equipment is provided for educational purposes only, and is to be used in accordance with Network and Internet Acceptable Use Agreements and Academy procedures and policies, including the student code of conduct.

2. Return of Equipment

I agree to return all High School provided technology equipment at the end of the school year or upon withdrawal from the High School. All technology equipment must be returned and checked in by an administrator.

If the technology equipment is not returned at the end of the school year, or when the student withdraws, or is expelled from the High School, I understand I will be responsible for the replacement cost of the equipment, and any repair costs associated with the equipment.

3. Personal Responsibility

I understand that I am responsible for my use of the provided technology equipment. I understand that I will be held personally responsible for damage or loss caused by abuse or negligence as determined by the High School administration. I understand that I will be responsible for full replacement cost if the technology equipment is damaged or lost.

I agree to report incidences of theft to the High School administration within twenty-four (24) hours of receiving knowledge of the loss.

I also understand that my communications over the internet and through email may be traceable back to the High School or to me. I will always use the provided technology equipment in a professional manner and in accordance with the terms of the Network and Internet Acceptable Use Agreement and High School guidelines and procedures.

I understand that my privilege to use High School provided technology equipment may be revoked, suspended, or limited at any time for any violation of this agreement, or any other violation of the academy's policies, student code of conduct or federal, state, or local laws. The High School will be the sole arbiter of what constitutes a violation.



4. Release

I release and agree to hold the High School, and all other sponsoring organizations related to the internet connection, from any and all liability foreseeable or unforeseeable for damages or injury resulting directly or indirectly from the use of the provided technology equipment.

I also agree to defend, indemnify, and hold harmless the High School, its Board members, staff, and agents from and against any such claims, demands, suits, damages, liability, costs, and expenses (including reasonable attorney fees) incurred as a consequence either directly or indirectly of the granting of this agreement.

5. Confirmation
